**Sub:- Refixation of Pay of AE's in the Grade Pay of Rs. 5400/- under MACP Scheme.**

**Ref: 1. Our meeting held with your goodself on dated 20.07.2010.  
2. Meeting of our association held with CEO on 23.07.2010.**

Madam,

During the course of discussions in the above noted two meetings, it was decided that refixation of Pay of AE's in the grade pay of Rs. 5400/- under benefit of MACP scheme shall be done within 15 days of the meeting dated 23.07.2010 held with CEO. Almost one month has elapsed and the concerned file regarding refixation is roaming about here & there in the hands of Consultants. We strongly demand removal of these private Consultants and to fix a date of DPC for refixation of pay w.r.t. AE's under MACP scheme as they are drawing less grade pay than EA's/SEA's and even lesser than Mast Tech.'s. who have been recently granted Grade Pay of Rs. 5400/- under MACP Scheme.

In order to remove this anomaly entailing grave injustice, we demand to fix the date of DPC failing which ADTEA would resort to coercive means like Dharna before your office on **19.08.2010** and again on **26.8.2010** if the circumstances necessitate.
