It is clarified that as per 6th Central Pay Commission, Revised Pay Rules-2008, under Note 2-A, Rule 7 "where a post has been upgraded as a result of the recommendation of the 6th CPC as indicated in Part- B or Part-C of the First Schedule of these rules are fixation of pay in the applicable pay band will be done in the manner prescribed in accordance with clause (A) (i) and (ii) of Rule 7 by multiplying the existing basic pay as on 01.01.2006 factor of 0.86 and rounding the resultant figure to the next multiple of 10. The Grade pay corresponding the upgraded scale of as indicated in the Column 6 of Part (B) or (C) will be payable in the edition. Illustration 4A in this regard is in the Explanatory Memorandum of these Rules."

Accordingly the matter can be settled.



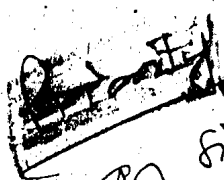

The matter regarding point no. 5 of the said minutes has been examined in the light of DOPT's instructions and accordingly it is clarified that as per 6th Pay Commission, Revised Pay Rules-2008, under Note 2-A, Rule 7 "where a post has been upgraded as a result of the recommendation of the 6th CPC as indicated in Part B or Part C of the First Schedule to these rules the fixation of pay in the applicable pay band will be done in the manner prescribed in accordance with Clause (A) (i) and (ii) of Rule 7 by multiplying the existing basic pay as on 1.1.2006 by a factor of .86 and rounding the resultant figure to the next multiple of ten. The Grade Pay corresponding the upgraded scale as indicated in Column 6 of Part B or C will be payable in addition. Illustration 4A in this regard is in the Explanatory Memorandum to these Rules."
