Your kind attention is invited over the pathetic condition of Subb. Engg Employees for last few years on certain issues. It is to inform you that AIR & DD Technical Employees Association is the oldest Association (since 1963) of subb. Engg. Staff representing Khalasi, Helper, Technician, Sr. Technician, Engg. Asstt., Sr. Engg. Asstt. and Asstt. Engineers , Besides these categories ADTEA also represent Diesel Engine Driver, Diesel Technician, Mast Technician, Carpenter and Sr. Carpenters of AIR & Doordarshan. We have a strong force of 6900 members which include 5000 life members and 1900 yearly paid members.

ADTEA is having its Units almost at all the stations of AIR & Doordarshan.

At present various issues pertaining to Subb. Engg. Employees are forwarded to the Ministry and no hearing is given either to the Directorate officials or representatives of ADTEA.

In almost all the pending issues , the Ministry view is not to accept and neither to reject the proposals send after lengthy meeting held between ADTEA & Prasar Bharati CEO, DG-AIR, DG-DD. In this regards a meeting with former MIB and ADTEA representatives was also conducted but issues are still waiting to reach at their logical conclusion.

We once again request your good self to kindly grant us an urgent meeting otherwise no option will be left for ADTEA except to launch nation wide agitation. We are submitting agenda items with the request to kindly grant us the meeting at the earliest.
